- Puppy sold as a pet with limited registration: Buyer agrees to have this puppy altered/neutered & has purchased this pup as a pet.
- Puppy sold as a show/breeding prospect with full registration:

This puppy is guaranteed to be in good health at the time of this sale and has had all vaccines and wormings that can be done in regard to his/her age. This information should be made available to your veterinarian at the time of the puppy's first visit to the vet you have chosen. It is strongly suggested that you take your puppy to the vet within 72 hours after taking your puppy home. We must be informed immediately if there are any findings of illness and/or congenital defects at the time of the first vet visit.

Alapaha Connection Kennels Contract (2)

- We DO NOT guarantee against conditions that may or may not be stress related from the move to a new home and/or by the shipping process. These stress related conditions that have previously remained dormant can be triggered by the above and unfortunately cannot be diagnosed until an active case becomes evident. Some of these stress related conditions: coccidia, hypoglycemia (low blood sugar) and kennel cough.
- Alapaha Connection Kennels guarantees that any puppy sold as a pet or as a show/breeding prospect will have a full three (3) year from date of sale health guarantee against disabling congenital defects and the following terms and conditions apply:
 - 1. In the event of a disabling congenital defect occurring the affected puppy must be returned to Alapaha Connection Kennels.
 - 2. Complete documentation from a licensed vet stating his/her diagnosis of the problem must be received at Alapaha Connection Kennels within one week from diagnosis having been made.
 - 3. Alapaha Connection Kennels reserves the right to have our vet confirm the diagnosis of a congenital defect at the purchaser's expense. Shipping costs are the responsibility of the purchaser.
 - 4. Alapaha Connection Kennels reserves the right to request that a puppy be returned immediately if any illness is evident within the first week after puppy leaves our premises. This applies to puppies picked up in person only as shipping is not an option if puppy is ill.
 - 5. Alapaha Connection Kennels must be contacted immediately if a puppy becomes ill in order for us to have the opportunity to lend our experience and opinion to the purchaser.
 - 6. Alapaha Connection Kennels will not be responsible for any costs incurred by the puppy purchaser after the puppy leaves our premises including any veterinarians costs, treatment costs, shipping fees or any other costs incurred by puppy purchaser.
 - 7. If Alapaha Connection Kennels is not contacted immediately in the case of a serious illness or other problem concerning the puppy this contract will become null and void as to any future claims.
 - 8. Alapaha Connection Kennels does not give money refunds.....replacement only.....same breed and sex.....contingent on availability.

Alapaha Connection Kennels Contract (3)

- 9. If a puppy purchaser desires to keep a puppy with a diagnosed congenital defect and the puppy requires a surgery to correct the problem and the surgery exceeds the cost of the puppy we will then offer another puppy free of charge to the puppy purchaser after the surgery has been performed and we have received all documentation concerning the surgery.
- 10. Alapaha Connection Kennels reserves the right to have our vet confirm that a surgery is needed in order for a puppy to have a happy normal life and also that the surgery has been performed before any other puppy is offered to the purchaser.
- 11. In the case of a fatality Alapaha Connection Kennels reserves the right to have a necropsy done by a vet or university of our choice before any replacement puppy is offered to the purchaser. After reviewing all findings a decision will be made by Alapaha Connection Kennels as to whether a replacement puppy is to be offered to the purchaser. All necropsy costs are the responsibility of the purchaser. A definitive cause of death must be found in order for a replacement to be given.
- 12. Alapaha Connection Kennels cannot fully guarantee that any puppy under the age of 6 months purchased as a show/breeding prospect will mature as a show/breeding prospect. Puppies go through many changes during development and something as simple as a bad bite may turn a show/breeding prospect into a pet puppy.
- 13. In the event of a show disqualifying fault (as per the standard of the breed) becoming evident in a puppy purchased as a show/breeding prospect the affected puppy must be returned to Alapaha Connection Kennels and a replacement puppy will be given to the purchaser as soon as one becomes available.
- 14. Registration paper will be provided at time of sale or forwarded by mail to the purchaser who purchases a show/breeding prospect puppy.
- 15. Any legal issues or court proceedings concerning the puppy purchased under this contract will be resolved in the State of California, City of San Diego, which is where the sale has been conducted. This extends to internet sales across state lines as well.

- 16. If at any time in the life of the puppy/dog concerned in this contract the seller becomes aware of a case of neglect and/or abuse of the same we reserve the right to retrieve the animal and find him/her a more suitable home.
- 17. If for any reason your puppy gets sick or dies before you receive your puppy, Alapaha Connection Kennels will take full responsibility. Alapaha Connection Kennels will not give cash refunds, but will offer a replacement puppy from the next available litter. This litter can be from different parents, unless you choose to wait for a litter from the same parents.
- ~All puppies must receive a full health exam and a health certificate in order to be shipped by air or ground transport across state lines. We consider this health certificate as proof that the puppy is free of communicable disease and/or sickness at time of sale. This health certificate can be no more than 10 days old at time of shipping. Shipping costs are always the responsibility of the purchaser.
